Sub :- Preparation of panel for the post of Inspectors (from CGST & CX) on deputation basis in the Directorate General of Goods and Service Tax, Mumbai.

The Directorate General of Goods and Service Tax, Western Zonal Unit, Mumbai is in the process of drawing up a panel of suitable and eligible officers to fill up the vacancies in the grade of Inspectors in the Directorate General of Goods and Service Tax, Western Zonal Unit, Mumbai. These posts will be filled up on deputation basis from amongst officers of the rank of Inspector working in the formations of GST & C.Ex. under the Central Board of Indirect Taxes and Customs.

2. Officers selected for a posting in the Directorate General of Goods and Service Tax would have a tenure of three years, extendable by maximum two years by the Director General of Goods and Service Tax. The age of the applicant shall be up to 57 years as on the date of this circular.

3. It is requested that this vacancy and communication may kindly be circulated among officers in your jurisdiction and the applications of willing officers may be forwarded to this Directorate. While forwarding the names of the willing officers, the following, information in respect of them may also be sent for evaluation by this Directorate :-


- Complete bio-data viz. Name, educational qualification, date of birth, present post and the date from which it is held including their history of postings and willingness of the officer.
- Their ACR gradation for the last 5 years or since the year of joining in the department.
- Vigilance Clearance.
- No objection from the Cadre Controlling Authority to relieve the officer/staff in the event of his/her selection.

4. The above information/details may kindly be furnished to this Directorate General on or before the close of office working hours on 15th March 2019.

5. While working in this Directorate, if the performance and/or conduct of the officer is not found to be satisfactory, the officer can be reverted to the Parent Commissionerate before completion of the aforesaid deputation period.
