**Subject:** Preparation of panel of Intelligence Officers (IOs) cadres for posting on loan basis in the Delhi Zonal Unit of Directorate General of Goods & Services Tax Intelligence.

Directorate General of GST Intelligence, Delhi Zonal Unit is in the process of drawing the panel of willing and suitable officers for filling up the vacancies in the grade of Intelligence Officer on loan basis from the officers of equivalent grades of Customs & Central Goods and Services Tax.

2. Normally the posting on loan basis is for a period of two years, which may further be extended for one year, subject to the willingness of the officer, his/her performance, concurrence of his parent commissionerate and approval of competent authority.
3. During the period of the posting on loan basis, the pay and other allowances of the concerned officer(s) shall be drawn from their respective parent Commissionerate(s).
4. It is requested that the circular may please be brought to the notice of all the formations under your jurisdiction and the applications of willing officers be forwarded to this office, while forwarding the names of the willing officers, the following information may also be sent for evaluation by this Directorate:
  - a. Complete bio-data and willingness of the officer alongwith history of posting.
  - b. ACR/APAR gradings for last 5 years (duly verified and attested by the Addl./Joint Commissioner)
  - c. Vigilance Clearance.
  - d. "No Objection Certificate" from Competent Authority for relieving the officer in the event of selection.
5. The above information/details may please be arranged to be furnished to the Directorate General by 30.11.2022.
