Dear *Colleagues,*

The 30th meeting of the GST Council was held today wherein various issues including GST Revenue Trends as well as E -Way bill/ Return filing were deliberated upon. Further, two briefs in the form of a Standard Operating Procedure (SOP) for the Tax Deduction at Source (TDS) for Government department, Local authority, etc.; and Frequently Asked Questions (FAQs) for Tax Collection at Source (TCS) by the e-commerce operators have been approved for publication. As you are aware the provisions relating to TDS/TCS are being introduced with effect from 1st October 2018. I would urge the Chief Commissioners / Directors General to ensure these publications are made use by the DDOs in the Department as well as for handholding of the trade. As regards registration by DDOs in CBIC under the TDS provision, I am sure the timelines would be met.

I am happy to inform that the Appointments Committee of Cabinet (ACC) has approved the empanelment for regular promotion in the grade of Commissioner of Customs & Central Excise for the vacancy year 2008-09 to 2011-12. This empanelment will cover officers in the 1988, 1989 and 1990 batches.

Yet another impressive initiative has been taken by CBIC in the area of infrastructure development. The Directorate General of Revenue Intelligence has obtained allotment of land measuring 6200 Sq. mt. for construction of office building at Vasant Kunj, Delhi from the Delhi Development Authority. While acknowledging and appreciating the sustained efforts undertaken by

DG, DRI and his team for this long due achievement, I am also certain that this would act as a strong motivation in pursuing infrastructure development by other field formations.

It is a matter of pride for us that Shri Nimesh Desai, Superintendent of Customs, Mumbai, Zone-I won a gold medal in Discus Throw and a silver medal in Shot Put at the recently concluded Asia Pacific Master games, 2018 held in Penang, Malaysia. I congratulate him on his scintillating performance.

Weekly reports on seizure of sensitive commodities by Customs formations are being furnished highlighting excellent seizures made every week. In this regard, I would urge all Chief Commissioners to bestow their personal attention in ensuring the accuracy and timeliness of these reports.

Shri Hemant A. Bhat, Principal Chief Commissioner, CGST Bhopal Zone is superannuating in this month. A small function to bid farewell to Shri Bhat was organised this week by the Members and other officers of the Board. On behalf of all the officers and staff of the Department, I wish him a peaceful and fruitful life ahead.
