Sub: Publication of Draft Seniority List of 'INSPECTORS' as on 31.08.2014

1. The inter-se-seniority of all the persons officiating in the grade of Inspector having the Pay Scale of Rs. 9300-34800 with grade pay of Rs. 4600/ under the Cadre Control of Central Excise, Delhi Zone as on 31 Aug 2014 has been compiled. Efforts have been made to avoid any error in this compilation. Copy of the Draft Seniority List so prepared is enclosed herewith.
2. Entries regarding the officers working in your jurisdiction may please be verified with the service records and any corrections required may be intimated to this office. It may please be thoroughly checked that no name which should have been included in the list is omitted. This would be the personal responsibility of the officer under whose jurisdiction the concerned officer(s) is/are working.

The Draft Seniority List has been updated on the basis of the information available with Cadre Control and may be circulated amongst all the officials concerned, and their signatures obtained for the purpose of record of their having seen the same. They may be informed that their representations relating to seniority position or changes to be made of any of the entries in the Seniority List are to be supported by relevant documents / proof and which are to be forwarded to this office after getting them examined / verified by their controlling officers latest by 25th Sep 2014. Wherever due, the rectification will be carried out in Final Seniority List on representations received through controlling officers. Representations sent by the officials directly to this office will not be entertained. The Draft Seniority List of Inspectors as on 31.08.14 of Central Excise, Customs & Service Tax of Delhi Zone has been placed on the website of CBEC i.e. www.cbec.gov.in and the details can be seen under ('Departmental Officers'>Seniority Lists') and Central Excise, Delhi-I website at centralexcisedelhi.nic.in.

A certificate to the effect that (i) the Draft Seniority List has been circulated amongst all the concerned officials who are working under your charge, (ii) the correctness of the entries in respect of them has been checked with the service records and (iii) name of the Inspectors working under your charge omitted in the seniority List, may please be sent to this office by 25th Sep 2014.
