**Subject: GST Council meeting on MSME Sector – Trade Representations and grievances on GST - reg.**


In the 28<sup>th</sup> GST Council Meeting held on 22<sup>nd</sup> July, 2018, it was decided to have a GST Council Meeting exclusively to focus upon the issues / hardships faced by Micro, Small & Medium Enterprises (MSME) related to GST tentatively on 4<sup>th</sup> August, 2018. The session would consider on all aspects of GST with specific focus upon law, policy, procedure, notifications, rates, GSTN related issues etc. effecting the MSME taxpayers / sector.

In this regard, you are requested to contact the MSME taxpayers and their trade & Industry Associations in your respective zones, collect their grievances / issues related to GST along with suggestions thereof for mitigating the issues.
