Please refer to the letter F. No. C-30013/84/2015 Ad IVA dt. 23rd Dec, 2016 (copy enclosed) from Jt. Secy (Admn.) regarding the above subject.

As you are aware, Department of Pension & Pensioners Welfare is implementing an online Pension Sanction and Payment Tracking System called 'BHAVISHYA'. The system provides for on-line tracking of pension sanction and payment process. The tracking can be done by the individual as well as the administrative authorities for all actions preparatory to grant of pension and other retirement benefits as well as monthly pension paid after retirement.

Bhavishya Portal will be connected through its website <https://bhavishya.nic.in>. Retiree will received login id and password through E-mail and SMS automatically. All DDOs & HOOs have to get registered on Bhavishya for login id and password. Bhavishya is to be used mandatorily in all Central Government (civil) departments with effect from 1.1.2017. You may please ensure that in no case pension case be delayed on account of non-familiarity with Bhavishya.

As on 31st March, 2017 about 750 DDOs had been registered in CBEC. As many **as 429 DDOs are yet to be registered** in the Bhavishya Portal on top priority. Nodal Officer Shri Sanjiv Kumar Singh, Jt. This is a top priority programme of the Govt. of India and is being monitored at the highest level. Hence, I would urge each one of you to ensure that all DDOs in your charge get registered **by 24th April, 2017** and a compliance report sent to Nodal Officer Shri Sanjiv Kumar Singh, Jt. Director, DGHRD, New Delhi by **26th April, 2017** positively.

Kindly refer to the D.O. letter of even number dated 23.12.2016 and D.O. letter from Member (A) dated 19.04.2017 regarding the "Implementation/Monitoring of Bhavishya Software in Ministries / Deptts. Including attached / subordinate officers.

2. As per DG,HRD report, only 932 Salary DDOs have been registered on Bhavishya and 221 DDOs are yet to be registered. This position is not satisfactory, and is viewed adversely by the DOP&PW.
