

Sir,

I am directed to refer to your letter no. C-50/08/2018-Ad.II, dated 5th April, 2018 and 10th April, 2018 and to state that the Commission in exercise of the power conferred on it by Article 324 of Constitution and Section 20B of the Representation of the People Act, 1951 appoints **Sh. Rohit Singla, IRS(C&CE):08 (R-17355), Sh. Tariq Mabood, IRS(C&CE):09 (R-22988) and Sh. Samaya Murali T, IRS (C&CE):08 (R-17369)** sponsored vide your letter no. C-50/08/2018-Ad.II, dated 12.03.2018, as Expenditure Observers for the General Election to the Legislative Assembly of Karnataka, 2018, announced by the Commission vide its Press Note no. ECI/PN/22/2018, dated 27.03.2018 (copy enclosed). The Commission has organized a briefing meeting for all appointed Expenditure Observers in **Pravasi Bhartiya Kendra, Auditorium Hall, 2nd Floor, Dr. Rizal Marg, Chanakyapuri, New Delhi-110021 on 11.04.2018.**

2. Under Section 13CC of the Representation of the People Act, 1950 and Section 28A of the Representation of the People Act, 1951, they will be deemed to be on deputation to the Election Commission from now till the completion of elections. Working as Observers of the Election Commission they will be subject to the control, superintendence and discipline of the Election Commission with respect to their duties performed as Observers.

3. Observers are entitled for TA/DA as admissible on tour. They will draw TA/DA from their Ministry/Department/Office. The expenditure will be debitable to the Budget grant of their Ministry or Department/Office. They are also entitled to travel by air by any scheduled commercial flight of any airlines. However, whenever they travel by train, it shall be as per their entitled class.

4. The Officers are also required to go through “Compendium of Instructions on Election Expenditure Monitoring (October, 2017)” available on the ECI website (http://eci.nic.in/eci_main/ElectoralLaws/compendium/EEM_Compndium_25102017.pdf). The sitemap of “Compendium of Instructions on Election Expenditure Monitoring (October, 2017)” is as mentioned below:-

Official ECI website-Link to the Observer's Portal (at the foot of the home page)- Home Page-Important Instructions for Expenditure Observer-Compendium of Instructions on Election Expenditure Monitoring (October, 2017).

5. The officers may be informed that-

(i) The officers are required to upload their photograph in the Personal Information Sheet on the Observer portal. This is required for printing of Identity Cards.

(ii) User id and password for accessing the Observer portal is 'Observer Code' mentioned against his/her name. The officers should change their passwords on first login, if they so wish.

(iii) The officers are requested to remain in contact with their Nodal Officer.

(iv) The deployment order indicating the State, District and Constituency shall be given during the briefing.

(v) Failure to attend briefing session may result in disciplinary action.

6. In this connection, I am directed to request you to intimate the officers immediately, with directions to ensure their presence in the Briefing Meeting in **Pravasi Bhartiya Kendra, Auditorium Hall, 2nd Floor, Dr. Rizal Marg, Chanakyapuri, New Delhi-110021 on 11.04.2018** without fail. The Expenditure Observers may be informed to report at **9:00 AM** for registration followed by briefing by the Commission.

7. The receipt of the letter by Expenditure Observers and the delivery of the same may be confirmed in writing to the Commission at the e-mail id given below by 10.04.2018 (F/N).
