**Subject: - Preparation of panel of Superintendent, Inspector & Tax Assistants cadres for posting on deputation in the Centre of Excellence, NACIN, New Delhi.**

Centre of Excellence, NACIN, New Delhi is in the process of drawing a panel of willing and suitable officers for filling up the vacancies in the grade of Superintendent(01 post), Inspector(01 post) & Tax Assistant(01 post) on deputation basis for a period of three years , which may be extended by two years.

2. It is requested to please bring this to the notice of all formations in your jurisdiction. The applications of officers need to contain their willingness, bio data and History of Postings. These are to be verified and attested alongwith APAR/ACR grading for last 5 years and accompanied by Vigilance Clearance Certificate and a "No Objection Certificate" from Competent Authority for relieving the officer in the event of selection. The complete application set may be forwarded by the Chief Commissioner's office. Advance copy of the willingness shall not be entertained.

3. If selected and appointed on deputation basis, officers shall be entitled to Deputation Allowance as applicable. The officer, who is selected, will have to make his/her own arrangements for residential accommodation. It may also be brought to the notice of the willing officers that once they are selected, they will not be allowed to withdraw their candidature. Further, in case, the work and conduct of the officer is not found to be satisfactory, the officer shall be reverted to his/her parent Department prematurely without assigning any reason.
