Sub : Preparation of panel for appointments as Senior Intelligence Officers on loan basis in the Directorate General of GST Intelligence, Zonal Unit, Pune-reg.

The Directorate General of Goods and Services Tax Intelligence (DGGI), Pune Zonal Unit is in the process of drawing up a panel of suitable officers for filling up vacancies in the grade of Senior Intelligence officers in Pune Zonal Unit including its Regional Units located at Kolhapur and Goa.

2. It is proposed to fill up the said posts on loan basis from amongst the officers of equivalent grade of Customs and CGST.
3. The loan period will be for 2 years initially and will not ordinarily exceed 3 years. The willing officers may expressly give their willingness for posting on loan basis. It may be made clear to the willing officers that the option once exercised would be final and in the event of selection in the Directorate General of GST Intelligence, they will not be allowed to withdraw the same.
4. Further, as per para IV of Ministry's letter F.No. A-35017/28/92-Ad.III-B dated 30.06.94, officers posted in certain charges/organisations/assignments are required to complete the "Cooling Off" period of not less than one year before posting in DGGI, PZU. However, the concerned Pr. Chief Commissioners/Chief Commissioners have been given the power to relax the "Cooling Off" period.
5. Name of eligible and willing officers may kindly be sent along with the following information:
 - a) Bio-data and willingness letter of the officer along with History of previous postings.
 - b) ACR grading for last 2 years.

c) Vigilance Clearance.

d) No objection from the Cadre Controlling Authority to relieve the officer in the event of his selection on loan basis.
