2. These posts will be filled on deputation basis for a period of three years. The deputation term may be extended further by two more years. The officers selected for deputation against the above posts will be entitled for Deputation Allowance @ 10% to the selected officers from formation not stationed in Hyderabad and @ 5% for officers from formations stationed in Hyderabad while working in this Directorate in terms of DOP&T's O.M.No. 2/11/2017-Estt (Pay-II), dated 24.11.2017.

3. It is requested that this Circular may please be brought to the notice of all the officers in the formations under your jurisdiction and the applications of willing officers obtained in the Proforma enclosed to this letter may be forwarded to this office along with the following particulars.

- i. Duly certified copies of ACR/APAR grading for the last five years
- ii. History of postings right from the joining in the Department.
- iii. Certificate of vigilance clearance
- iv. It may also be certified that no vigilance/non-vigilance cases are pending or being contemplated in respect of the officer as per the entries made in the Service Book.
- v. No objection certificate to relieve the officer in the event of his/her selection from the cadre controlling authority.

4. It may be made clear to the willing officers that option once exercised will be final and in the event of selection, they will not be allowed to withdraw the same and they are expected to serve NACIN, Hyderabad till expiry of the full tenure of 3 (three) years.


5. In case, while working in this Directorate, if the conduct and / or work performance of the officer is not found satisfactory, the officer shall be liable to be repatriated to the parent Commissionerate/Directorate without assigning any reasons.

6. The applications received after the closing date would not be eligible for being considered.

7. The Circular may please be widely circulated among all officers and the applications of the willing officers in the Proforma along with the other details as mentioned above, may be forwarded to this office on or before 08.10.2021.

8. The willing officer may send advance copy of his/her application to the Additional Director General, NACIN, Hyderabad but his/her application would be considered only on receipt of his/her duly forwarded application from the Cadre Controlling Authority on or before the last date.
