2. These posts will be filled up on deputation/loan basis from amongst the willing officers working in the formations of Central GST/Customs (or) holding analogous posts in the Directorate General / Directorates of CBIC in the same

pay scale. The Officers appointed on Deputation basis will also be eligible for Deputation allowance, as applicable.

3. The officers selected on deputation basis in the Directorate General of Audit would normally be appointed for a period of 3 years, which is extendable by another two years. The officers selected on loan basis would normally be appointed for a period of 2 years, which is extendable by another 1 year.

4. Applications of the eligible and willing officers may be forwarded to this office with their particulars viz.


1. Name of the Officer.
2. Educational qualification.
3. Date of birth.
4. Present post held and formation.
5. Date from which held.
6. Scale of pay.
7. Work Experience from the date of joining the department.
8. APAR gradings for the last 5 years.
9. Vigilance clearance Certificate.

It may also be brought to the notice of the willing officers that once they are selected, they will not be allowed to withdraw their name and will not be relieved till the expiry of the deputation/loan tenure.

5. If the work and conduct of the officer is not found to be satisfactory, the officer is likely be repatriated to the parent Commissionerate/Directorate much before the completion of the deputation/loan period.

6. It is requested that this letter may be widely circulated among the officers under your jurisdiction. The last date for receipt of applications complete in all aspects is 30th November, 2021.
