**Sub: Preparation of panel for deputation basis as Additional Assistant Directors/Superintendents in the Directorate General of Performance Management, Eastern Regional Unit, Kolkata –reg.**

The Directorate General of Performance Management, Eastern Regional Unit, Kolkata is in the process of drawing up a panel of willing and suitable officers for filling up the post of “Additional Assistant Director/Superintendent” at Eastern Regional Unit, Kolkata, on deputation basis as mentioned below. It is proposed to fill the vacancy by appointing suitable officers from the respective grades of Customs and CGST formations.

The selected officers, while working in the Directorate General of Performance Management, Eastern Regional Unit, Kolkata on deputation basis, will be entitled for Deputation Allowance as admissible in terms of OM No. 2/22(B)/2008\* Estt. (Pay II) dated 3<sup>rd</sup> September, 2008 (as amended) of Ministry of Personnel, Public Grievances and Pensions, DoP&T, New Delhi.

3. Normally, the deputation is for a period of three years to the post of “Additional Assistant Director/Superintendent” which is extendable by another two years, subject to the willingness of

the officer, his/her performance, concurrence of his/her parent Commissionerate and approval of the Competent Authority.

4. It is requested that this Circular may please be brought to the notice of all the formations under your jurisdiction and application of willing officers may be forwarded to this office. While forwarding the names of the willing officers, the following information in respect of them may be furnished for evaluation by this Directorate.

- a) Complete Bio-data and willingness letter of the officer along with history of previous postings;
- b) ACR/APAR grading preferably for the last five (5) years duly verified and attested by the Additional/Joint Commissioner (P&V);
- c) Vigilance Clearance Certificate; and
- d) No Objection Certificate from the Competent Authority to relieve the officer in the event of his/her selection.

5. The last date for receipt of application is **19.03.2020**.
