Sub: Preparation of panel for appointment of Senior Intelligence Officers and Intelligence Officers on Deputation basis in the Directorate of Revenue Intelligence, Hyderabad Zonal Unit - reg.

The Directorate of Revenue Intelligence, Hyderabad Zonal Unit is in the process of drawing up a panel of suitable candidates for filling up the existing/anticipated vacancies in the grade of Senior Intelligence Officer (Pay Level – 8/9) and Intelligence Officer (Pay Level – 7) in DRI, Hyderabad Zonal Unit to be posted at Hyderabad. These posts will be filled up on deputation basis from the officers of equivalent grades of Superintendent/Appraisers and Inspectors/Preventive Officers/Examiners of Customs & Central GST.

- The selected officer on deputation while working in the Directorate will be entitled to deputation allowance as admissible. Normally, the deputation is for a period of five (05) years which may be extended further by two more years, subject to the willingness of the officer, his/her performance and the concurrence of his/her parent Commissionerate and approval of the Competent Authority.
- It may be made clear to the willing officer that the option once exercised would be final and in the event of his selection, he/she will not be allowed to withdraw the same.
- Further, as per Para IV of Ministry's F.No. A-35017/28/92/ADS.III.B dated 30.06.1994 officers posted in certain charges / organizations / assignments are required to complete the "cooling off" period of not less than two years before posting in Directorate of Revenue Intelligence. However,

the concerned Chief Commissioner of Customs / Central GST has been given the power to relax the "Cooling off" period.

5. It is requested that this Circular may please be brought to the notice of all the formations under your jurisdiction and the applications of willing officers may be forwarded to this office. While forwarding the names of the willing officers, the following information in respect of them may also please be enclosed for evaluation:

- i. Complete Bio-data (format enclosed) and willingness letter of the officer;
- ii. History of Previous Postings;
- iii. APAR/ACR Grading for the last 5 years duly verified and attested by the Additional/Joint Commissioner (P&V);
- iv. Vigilance Clearance Certificate; and
- v. 'No objection Certificate' from the Cadre Controlling Authority to relieve the officer in the event of his/her selection.
