Sub: Preparation of panel of Inspectors for posting on loan basis in O/o the Chief Commissioner (AR), CESTAT, New Delhi (Hqrs.) and its zonal offices – reg.

The O/o Chief Commissioner (AR), CESTAT, New Delhi proposes to draw up a panel of willing and suitable officers for filling up the vacancies in the grade of Inspectors for posting on loan basis at its Hqrs. office at Delhi and zonal offices located at Mumbai, Kolkata, Bangalore, Allahabad, Ahmedabad and Chandigarh for an initial period of 02 (Two) years. The said period may be extended in accordance with the existing rules/instructions.

2. It is requested that the same be circulated to all formations in your Zone and applications be obtained from willing officers in the Zone. Applications of suitable officers in the grade of Inspectors should contain their willingness, bio-data and history of postings. The history of postings should be verified and attested and send along with “APAR/ACR gradings” for the last 05 (Five) years, “Vigilance Clearance Certificate” and a “No Objection Certificate” from the CCA. The complete application set may be forwarded by the Pr. Chief/Chief Commissioner’s Office on or before 31.01.2022 to this office. Advance copy of applications received directly from the officers shall not be entertained.

3. If selected and appointed on loan basis, the officer shall not be entitled to any special allowance. The officer who is selected will have to make his/her own arrangements for residential accommodation. It may be brought to the notice of the officers that once they are selected, they will not be allowed to withdraw their option till the expiry of their tenure. In case the conduct and work of the officer is not found satisfactory while working in O/o the Chief Commissioner (AR), CESTAT, New Delhi or its zonal offices, the officer shall be reverted prematurely without assigning any reason.
