Sub: Filling vacancies in the grade of Superintendents and Inspectors on loan basis in the Zonal Campus of National Academy of Customs, Indirect Taxes & Narcotics, Bhubaneswar – Regarding

Applications from suitable candidates are invited for the post of Superintendents and Inspectors for filling vacancies in the Zonal Campus of National Academy of Customs, Indirect Taxes & Narcotics, Bhubaneswar on loan basis. In the case of officials selected and appointed, the initial appointment would be for a period of two years, which may be further extended for one year. The pay and allowance would be drawn by parent commissionerate and there would not be entitlement to any special allowance/deputation allowance, etc. It is pertinent to state that it has been clarified by the CBEC letter F.No. A-11013/12/2019-Ad.IV dated 27.05.2020 as amended vide letter dated 17.12.2020 that every CCA shall have a specified percentage i.e. 10% out of their sanctioned strength (round of to nearest number) meant for posting on loan basis to directorates, who may be posted to Directorates outside the jurisdiction of said CCA at the discretion of the Chief Commissioner of the Zone.

The applications of the officers need to contain their willingness, bio-data and history of postings. These are to be verified and attested along with APAR/ACR grading extending up to the previous 5 years and accompanied by vigilance clearance certificate and a “No Objection Certificate” from the Zonal CCA for relieving the

officer in the event of selection. The complete application set is to be forwarded through the concerned Chief Commissioner's office to the Zonal Campus of National Academy of Customs, Indirect Taxes & Narcotics, Bhubaneswar by 23.04.2021. It is imperative to mention that no action in the matter will be initiated on advance copies received in this office without 'NOC' from the Zonal CCA.
