2. These posts will be filled up on loan basis from amongst the officers of similar rank working under GST & Central Excise/Customs formations and officers holding analogous posts in the Directorates under CBIC in the same pay scale.

It is requested that application of interested and eligible officers may be forwarded to this office [addressed to Deputy Secretary (Customs) at dircus@nic.in], with their names and details as per annexure A and also `No Objection Certificate` from the concerned Commissionerate/ Director General/Directorate along with synopsis of their APAR grading for the last 3 years within 30 days of issue of this circular. It may also be certified that no vigilance case is pending or is being contemplated against the officer.
4. The selected officers will have to make their own arrangements for residential accommodation.
5. While working in Customs Policy wing, if the work and conduct of the officer is not found satisfactory, the officer can be reverted to the parent Commissionerate/ Directorate before completion of the loan period.
6. The officers selected on loan basis will continue to draw their salary and other allowances from their parent Commissionerate/Directorates as per rule.
