It is proposed to draw a panel of suitable and eligible officers to fill up the anticipated vacancy of 03 Superintendents & 03 Inspectors (from CGST & CX) in the office of Directorate General of Valuation, Mumbai. These posts will be filled up on deputation basis from amongst officers of above ranks (i.e. Superintendents/Inspectors) working in the formations of GST and Directorates under Central Board of Indirect Taxes & Customs.

2. Such officers selected for a posting in the Directorate General of Valuation would initially be for a period of three years, extendable by maximum two years by the Director General of Valuation. The age of the applicant shall be up to 56 years as on the date of this circular. Officers having the following work experience and exposure will be preferred.

- i) Knowledge of the Customs Act, 1962 and Customs Valuation Rules.
- ii) Having exposure to Data Base Management System.
- iii) Working experience of Website Management.
- iv) Knowledge of Computer Operation and Server Management.

3. Further, the officer selected for the deputation post at Mumbai Headquarter (Inspector) and at the

South Zonal Unit – Chennai (Superintendent) would be entitled to deputation allowance as per the prevailing rules for the said post.

4. It is requested that this vacancy and communication may kindly be circulated among officers in your jurisdiction and the applications of willing officers may be forwarded to this Directorate. While forwarding the names of the willing officers, the following, information in respect of them may also be sent for evaluation by this Directorate:-

- a) Complete bio-data viz. Name, Educational Qualification, Date of Birth, Present Post and the Date from which it is held including their history of postings and willingness of the officer.
- b) Their ACR gradations for the last 5 years.
- c) Vigilance Clearance.
- d) No Objection from the Cadre Controlling Authority to relieve the officer/staff in the event of his/her selection.

6. In case, while working in this Directorate General of Valuation the work and conduct of the officer is not found to be satisfactory, the officer can be reverted to the parent Commissionerate before completion of the aforesaid deputation period.
