विषय/Subject: Preparation of panel for appointment of Intelligence Officer (IO) on deputation basis in the Directorate General of Goods and Service Tax Intelligence, Rourkela Regional Unit, Rourkela - willingness called for – regarding.

- 1. The Directorate General of Goods & Service Tax Intelligence (DGGI), Bhubaneswar Zonal Unit is in the process of drawing up a panel of willing and suitable officers for filling up two (2) vacancies in the grade of Intelligence Officer (IO) on deputation basis, to be posted at DGGI, Rourkela Regional Unit, Rourkela.
- 2. The selected officer, while working at DGGI in the grade of IO on deputation basis, will be entitled for Deputation Allowance, as admissible. Normally, the deputation is for a period of five years, subject to the willingness of the officer, his/her performance, concurrence of his/her parent Commissionerate and approval of the competent authority. It may be made clear to the willing officers that the option once exercised, would be final and in the event of selection, he/she will not be allowed to withdraw the same. Officers having minimum three (3) years of experience in the grade of Inspector may exercise their willingness through proper channel. Experience in Preventive/Anti-evasion are preferable.
- 3. It is requested that this circular may be brought to the notice of all the formations in your jurisdiction and the application of the willing officers be forwarded to this Zonal Unit. While forwarding the name of the willing

officer(s), the following information in respect of officer may also be sent for evaluation by this Directorate viz.:

- (a) Complete Bio-data and Willingness letter of the officer along with history of posting;
- (b) ACR/APARs grading for the last (5) five years duly verified and attested by the additional/Joint Commissioner (P&V);
- (c) Vigilance Clearance Certificate; and
- (d) No Objection Certificate from the Competent Authority to relieve the officer in the event of his/her selection.
- 5. Willing officer may send advance copy of his/her application/willingness addressed to the Additional Director General, Directorate General of GST Intelligence, Bhubaneswar Zonal Unit, Plot No. 27, Saheed Nagar, Bhubaneswar-751007.
- 6. In case, while working in this Directorate, if the conduct and work of the officer is not found satisfactory, the officers shall be reverted to their parent Commissionerate prematurely without assigning any reasons.
- 7. The above information/details may please be arranged to be furnished to the Directorate at earliest, preferably by **29.07.2022.**
