**Sub : Preparation of panel for appointment for various posts
 on deputation in the Directorate of Revenue Intelligence,
 Mumbai Zonal Unit – reg.**

The Directorate of Revenue Intelligence, Mumbai Zonal Unit, Mumbai is in the process of drawing up a panel of suitable officers for filling up vacancies in the following grades in Mumbai Zonal Unit including its Regional Units :-

Sr. No.	Designation	Number of Posts
1.	Pvt. Secretary	1
2.	Executive Assistants (STA)	6
3.	Tax Assistants	3
4.	LDC	1
5.	Steno Gr. I	2
6.	Driver All Grades	5
7.	Hawaldars/ Head Hawaldars	7
8.	MTS (Multi Tasking Staff)	2

2. It is proposed to fill up the said posts on deputation from amongst the officers of equivalent grade of Customs and CGST.

3. The deputation period will be for 5 years initially and will not ordinarily exceed 7 years. The willing officers may expressly give their willingness for posting on deputation. It may be made clear to the willing officers that the option once exercised would be final and in the event of selection in the Directorate of Revenue Intelligence, they will not be allowed to withdraw the same.

4. Further, as per para IV of Ministry's F.No. A-35017/28/92-Ad.III-B dated 30.06.94, officers posted in certain charges/organisations/assignments are required to complete the "Cooling Off" period of not less than one year before posting in DRI. However, the concerned Pr. Chief Commissioners/Chief Commissioners have been given the power to relax the "Cooling Off" period.

5. Name of eligible and willing officers may be sent alongwith the following information :
- a) Bio-data and willingness letter of the officer alongwith History of previous postings.
 - b) APAR gradings for last 5 years
 - c) Vigilance clearance
 - d) No objection from the Cadre Controlling Authority to relieve the officer in the event of his/her selection on deputation basis (Both)
 - e) Pr. Chief Commissioner's/Chief Commissioner's concurrence and permission to relax the "Cooling Off" period, wherever necessary.
