Subject: Preparation of panel for appointment of Senior Intelligence Officers and Tax Assistant on Deputation basis in the Directorate General of Goods & Service Tax Intelligence, Raipur Zonal Unit (Chhattisgarh).

The Directorate General of GST Intelligence, Raipur Zonal Unit (DGGI, RZU) is in the process of drawing a panel of suitable officers for filling up following vacancies.

S. No.	Post	Vacancy on deputation
1	Sr. Intelligence Officer	01
2	Intelligence Officer	03
3	Tax Assistant	01

2. The number of vacancies may be increased or decreased at the discretion of the Competent Authority.
3. The said vacancies are to be filled up by appointing suitable officers of equivalent grade on Deputation basis. Normally, the deputation is for the period of five years from the grade of Superintendent, Inspector and Tax Assistant, which is extendable by another two years, subject to the willingness of the officer, his/her performance, concurrence of his/her parent Commissionerate and approval of the Competent Authority as per extant guidelines of DGGI/CBIC.
4. The selected officer, while working in the Directorate General will be entitled for deputation allowance as admissible in terms of Ministry of Personnel, Public Grievances



and Pensions, DoP&T, O. M. No. 2/22(B)/2008-Estt.(Pay-II) dated 03.09.2008 (as amended) read with DoP&T, O. M. 2/11/2017-Estt(Pay-II) dated 24.11.2017.


5. It may be brought to the notice of the Officers that once they are selected, they will not be allowed to withdraw their option. In case, while working in the Directorate, if the conduct and work of the officer is not found satisfactory, the officer shall be reverted to their parent Commissionerate prematurely without assigning any reasons. The officers may exercise their willingness through proper channel.

6. It is requested that the circular may be brought to the notice of all the formations under your jurisdiction and the application of willing officers / staff be forwarded to this Zonal Unit. While forwarding the name of the willing officers/ staff, the following information in respect of his/her may also be sent for evaluation by this Directorate.

- (i) Complete Bio-data and willingness of the officer along with history of posting;
- (ii) ACR/APAR grading for the last five years duly verified and attested by the Additional/Joint Commissioner(P&V);
- (iii) Vigilance Clearance Certificate;
- (iv) NOC from the Cadre Controlling Authority to relieve the officer in the event of his/her selection.
