Sub: Preparation of Panel for selection to the post of Inspector (01) on deputation in the Directorate General of Anti-profitteering, New Delhi.

It is proposed to draw a panel of suitable and eligible officers for the post of Inspector (Level 7) to be filled up on deputation basis, in the Directorate General of Anti-profitteering, New Delhi.

2. The period of deputation for the selected person, shall not exceed three years from the date of assumption of charge under normal circumstances, which may be extended to a maximum of 5 (five) years, subject to satisfactory performance. The officers on deputation will be entitled to a Deputation Allowance @ 5%/10% of their basic pay during the tenure of their posting as Inspector, as the case may be in this Directorate. Cadre control for the purpose of promotion etc. of such staff would continue to be with the parent cadre controlling Commissionerate to which such deputed person belongs. The Directorate General of DGAP, however, reserves the right to revert the officer at any time without assigning any reason.

3. It is requested that this letter may be given wide circulation and application from interested Inspectors under your jurisdiction may be forwarded to this Directorate as per the enclosed format alongwith ACRs/APARs grading of last five years, vigilance clearance and no objection to release the officer in the event of his/her appointment on deputation basis.

4. The last date of receipt of complete application form through proper channel is 10.08.2022. No advance application will be entertained.
