विषय/Subject: Preparation of panel officers for appointment on loan basis to the Grade of Additional Assistant Director (AAD) and Intelligence Officer (IO) in the Directorate General of Goods and Service Tax Intelligence, Bhubaneswar Zonal Unit- willingness called for - reg.

1. The Directorate General of Goods & Service Tax Intelligence (DGGI), Bhubaneswar Zonal Unit and Rourkela Regional Unit are in the process of drawing up a panel of willing and suitable officers/staff for filling up the existing vacancy in the grade of Additional Assistant Director (ADD) and Intelligence Officer (IO) on loan basis.
2. It is proposed to fill up these vacancies by appointing willing and suitable officers on loan basis, for the period of two years from the grade of Superintendent / Inspector. The officers, who have been granted financial up-gradation under MACP scheme, are also eligible to apply.
3. It is requested that this circular may be brought to the notice of all the formations in your jurisdiction and the application of the willing officers be forwarded to this Zonal Unit. While forwarding the name of the willing officers, the following information in respect of officer may also be sent for evaluation by this Directorate.
  - (a) Complete Bio-data and Willingness letter of the officer.
  - (b) History of Posting.

- (c) ACR/APARs grading for the last (5) five years duly verified and attested by the additional/Joint Commissioner (P&V).
- (d) Vigilance Clearance Certificate; and
- (e) No Objection Certificate from the Competent Authority to relieve the officer in the event of his/her selection.

4. It may be brought to the notice of the officers that once they are selected, they will not be allowed to withdraw their option and they are expected to serve in DGGI, Bhubaneswar Zonal Unit, Bhubaneswar and DGGI, Rourkela Regional Unit, Rourkela till the expiry of their tenure of 2 (two) years.

5. Willing officers/staff may send advance copy of his/her application/willingness addressed to the Additional Director General, Directorate General of GST Intelligence, Bhubaneswar Zonal Unit, Plot No. 27, Saheed Nagar, Bhubaneswar-751007.

6. In case, while working in this Directorate, if the conduct and work of the officer is not found satisfactory, the officers shall be reverted to their parent Commissionerate prematurely without assigning any reasons.
