4. It may be brought to the notice of officers that once they are selected, they will not be allowed to withdraw their option and they are expected to work in NACIN, ZTI, New Delhi, till the expiry of the deputation tenure or their repatriation, whichever is earlier.
5. In case while working in this office, if the conduct and work of any officer is not found satisfactory, the officer shall be repatriated to their parent Commissionerate prematurely without assigning any reason.
6. Selected officers will have to make their own arrangement for residential accommodation.


