Sub: Preparation of panel for appointment of Intelligence Officer
on deputation basis in the Directorate General of GST
Intelligence (DGGI), Bengaluru Zonal Unit – Regarding

The Directorate General of GST Intelligence, Bengaluru Zonal Unit is in the process of drawing up a panel of suitable candidates for filling up 7 (Seven) vacancies of Intelligence Officer (Pay Level-7) on deputation basis in the Zonal Unit by appointing suitable officers from the grade of Inspectors in Customs & Central Tax (Govt. of India).

2. The selected officers while working in DGGI, Bengaluru Zonal Unit on deputation basis will be entitled for deputation allowance, as admissible, in terms of OM No. 2/11/2017-Estt.(Pay-II) dated 24.11.2017 of Ministry of Personnel, Public Grievances & Pensions, DOP & T, New Delhi. Normally the Deputation tenure is for an initial period of 5 (Five) years which can be further extended for another 2 (Two) years, subject to the willingness of the officer, his/her performance, concurrence of his/her parent Commissionerate and the approval of the Competent Authority. It may be made clear to the willing officers that the option once exercised would be final and in the event of selection, he/she will not be allowed to withdraw the same.

- (iv) No Objection Certificate to relieve the officer in the event of his/her selection from the Cadre Controlling Authority.
