Subject: - Preparation of panel of Tax Assistants & Stenographer Gr. I cadres for posting on deputation in the Centre of Excellence, NACIN, New Delhi.

Centre of Excellence, NACIN, New Delhi is in the process of drawing a panel of willing and suitable officers for filling up the vacancies in the grade of Tax Assistant (01 post) & Stenographer Gr. I (02 posts) on deputation basis for a period of three years, which may be extended by two years. In case sufficient number of Stenographer I are not available, Stenographer II may also be considered.

2. It is requested to bring this to the notice of officers at these levels posted in all formations under your jurisdiction. The applications of officers need to contain their willingness, bio data and History of Postings. These are to be verified and attested alongwith APAR/ACR grading for last 5 years and accompanied by Vigilance Clearance Certificate and a "No Objection Certificate" from Competent Authority for relieving the officer in the event of selection. The complete application set may be forwarded by the Pr. Chief/Chief Commissioner's office. **Advance copy of the willingness shall not be entertained.**

3. If selected and appointed on deputation basis, officers shall be entitled to Deputation Allowance as applicable. The officer, who is selected, will have to make his/her own arrangements for residential accommodation. It may also be brought to the notice of the willing officers that once they are selected, they will not be allowed to withdraw their candidature. Further, in case, the work and conduct of the officer is not found to be satisfactory, the officer shall be reverted to his/her parent Department prematurely without assigning any reason.

4. The last date for receiving the applications of willing and eligible officers, alongwith the duly verified and attested APAR/ACR grading for last 5 years and accompanied by
