Subject: Combined Graduate Level Examination (CGLE), 2019- Final confirmation of vacancies for the post of Inspector (CGST, PO & Examiner) and TA- reg.

Please refer to your letter F.No. A.12034/SSC/01/2020-Ad.III(B) dated 09.08.2021 on the above mentioned subject.

2. This office vide letter F.No. 8/B/73/HRD(HRM-II)/2019 dated 10.08.2021 asked for final confirmation of vacancies for CGLE-2019 from all Cadre Controlling Authorities, for the post of Inspectors((CGST), Preventive Officer(Customs), Examiner(Customs)) & Tax Assistant(Customs & CGST).

3. Mumbai CGST, Vadodara CGST, Jaipur CGST & Lucknow CGST have informed no change in earlier reported vacancies. Further, Mumbai CGST has informed that the Surplus officers assigned to them will be adjusted in future vacancies. Also, Vizag zone confirmed the additional candidate allocated to them has joined and total vacancy position in grade of PO stands as 19.

4. Further, Guwahati CGST & Goa CGST updated the vacancies in the grade of Inspector & Tax Assistant.
