The officers who have got MACP to higher level are also eligible to apply for the under mentioned posts.

It may also be brought to the notice of the willing officers that once they are selected, they will not be allowed to withdraw their names and also will not be relieved till expiry of the tenure of the three years. Selected officers will have to make their own arrangement for accommodation and other related facilities.

While working in the Directorate, if the work and conduct of the officer(s) is found to be unsatisfactory, the officer(s) is likely to be reverted to the parent Commissionerate/Directorate even before the completion of the deputation period.
