2. However, it has been observed that as on date, very few judgments have been uploaded on CBIC website.

3. It is to further state that the format was devised in a manner so that the issue could be grasped at a glance by the field officers and the detailed order could be referred in case of need. However, it is observed that, in most cases, gist of the judgment has not been provided to convey the issue/ratio. Some zones have simply forwarded the judgments without reference to the format. To obviate the problem in future, it has been decided to accept information sent with approval JC/ADC.

4. I am further directed by the Member (Legal) to get data-base of HC judgments updated till April, 2022 at the earliest.
