In the current fiscal year 2022-23, CBIC has earmarked Rs. 60 crore for Swachhta Action Plan (SAP) under the head O.E. (Swachhta) which has already been allotted to all the Budgetary Authorities under CBIC. I would request you to ensure that a concrete action plan is drawn by all the formations in your jurisdiction, so that funds in O.E. (Swachhta) for the Fiscal Year 2022-23 are meaningfully utilized and we contribute to Swachhta Action Plan in a committed manner. It is also requested that all the formations within your jurisdiction identify the Swachhta Projects for the fiscal year 2022-23 and upload the same in the Swachhta@CBIC Tab by 31st May 2022. A list of Swachhta activities which could be replicated where feasible is also enclosed as Annexure A.

2. For selection of best performing GST Zones, Customs Zones, Directorates & Commissionerates in 2021-22, the Swachhta projects shall be evaluated using highly objective & scientific methodology. As details of the projects undertaken by the formations are already available in the swachhta@CBIC Tab (<https://www.dghrdcbic.gov.in/swachh/>) evaluation will be done on the basis of the broad category of the projects and the photographs uploaded in the e-module. However, if any formation may like to highlight any project which is not possible to convey with the help of the module, then a separate email or a letter can be sent on swachhta-dghrd@gov.in to ADG, HRM-II, DGHRD by 25.05.2022 mentioning the salient features and highlights.

3. I look forward to a positive response so that CBIC may contribute substantively towards achieving the goal of 'Swachh Bharat Shreshta Bharat'.
