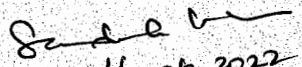

4. The reserve price for bid will be **Rs.16,625/-**.
5. No items once disposed to the successful bidder shall be taken back by this Department on any condition whatsoever.
6. The successful bidder will be required to pick up the items from the disposal site mentioned above within **five days after making the payment to the Department**. On failure to do so, this office shall have the right to forfeit the entire amount of the bidder and dispose of the items through the alternative bidder. The successful bidder, on his own cost, will also require to make his own arrangement of transport, labour etc. for picking the disposed items.
