The Financial Bids shall be opened on the same day, of only those bidders whose Technical Bids are qualified and the lowest bidder, fulfilling all the criteria, shall be chosen based on the amount/rate quoted.

(Scope of work)

1. A. The bidder should repairing works of 12 (Twelve) nos. of class rooms and also complete school building walls repairing with painting
B. Replacement of 20 (Twenty) nos. of broken window glasses of S.B.Girl's High School, Recognised by W.B.Board of Secondary Education, 393, Raja S.C.Mullick Road, Kolkata - 700047.
2. The proposed repairing, painting & replacement of window glasses should be completed by the bidder using a good quality bricks & completed with plastering using cement of a reputed brand (ACC/Ambuja/Ultra Tech/Lafarge & Like).
