Terms and conditions-

4. The sealed tenders received after the stipulated date and not in the prescribed format will not be entertained.
5. The subcontracting of work is not allowed.
6. The rates quoted will remain in force till the completion of the job. No demand for revision of rates on any account shall be entertained.
7. The Department reserves the right to cancel the bid, if any information provided by the contractor is found unverifiable during the selection procedure. The office also does not bind itself to accept the lowest tender and it reserves the right to reject any or all of the tenders without assigning any reason whatsoever.
8. The firm must be registered with tax authority / GST or an undertaking to be produced to the effect that they are liable to pay tax or to be registered.
9. Payment will be done on completion of the project.
