Sub: Slow-Utilization of funds allocated for Swachhata Action Plan (SAP) - Reg.

The Secretary (Expenditure) vide letter dated 01.01.2018 {received in DGHRD on 18.01.2018 through Director (IFU) O.M. of F.No. 6/1/2018/IFU-EC dated 10.01.18} has conveyed that during a review meeting of the Committee of Secretaries (CoS) on 'Swachhata Action Plan (SAP)', 2017, concern has been expressed about <u>under-utilization of funds earmarked for Swachhata Action Plan (SAP)</u>during the first two quarters of this FY.

- 2. A copy of Expenditure progress (uptil Dec.2017) of each Zone is enclosed. It appears that there is Slow-Utilization of funds allocated for Swachhata Action Plan in most Zones so far. A total of 05.28 cr. only has been spent as against 45.00 cr. allocated for this purpose.
- 3. Kind attention is also invited to Chairman, (CBEC), D.O. letter dated 17.01.2018 addressed to all CCs/DGs (issued vide D.O. No. 916/12/Const/Zonal Members/HRD/17) for personally monitoring the work related to SAP and to ensure that significant results are achieved.
- 4. Hence,in view of the observations of the Committee of Secretaries and the advisory of Chairman, (CBEC), the projects under SAP, 2017 may kindly be accorded utmost importance and ensure that the allocated funds are fully utilized during the current financial year. The expenditure progress may be reflected in the Monthly Expenditure Reports (MER) of January/February, 2018 addressed to EMC, DGHRD for reporting the progress to the Committee of Secretaries.
