Sub: Vacancy for the post of Revised Kyoto Convention (RKC) Review Expert in Compliance and Facilitation Directorate in World Customs Organisation, Brussels-Calling application of suitable eligible officers-reg.

The World Customs Organisation (WCO) vide a letter dated 25.08.2020 has advertised a vacancy for the post of Revised Kyoto Convention (RKC) Review Expert in Compliance and Facilitation Directorate of World Customs Organisation, Brussels. This vacancy notice is for a contractor position funded from the WCO Reserves, to assist in continuing the Review of the RKC, which will be vacated from September 2020. The duration of appointment for the said post will be upto June 2021 (possibility of extension).

2. The project background, main accountabilities, educational qualification, experience, contract conditions, application and the recruitment process_etc for the post, as prescribed by WCO are given in **Annexure-A** and the application form is in **Annexure-B**. Further, the applicant has also to fill the attached **proforma**.

3. The contract offered to the successful candidate will include a salary equivalent to that of a Technical Officer (Grade A3 step 1). As it is a long term foreign assignment (more than 90 days) the applicant should have completed nine years (09) of service in his/her cadre.

4. In this regard, you are requested to forward the application of willing and suitable eligible officers who fulfil the criteria specified by WCO along with **vigilance clearance** and **APAR grading for the last five years** from your side. Applicants are requested to apply through proper channel only and no advance applications will be entertained. The application in pdf format should be sent by e-mail to indiaawco-cbec@nic.in with a copy to Hardeep.Batra@gov.in. The nominations should be sent as soon as possible but not later than **4th of September 2020**. Incomplete applications and those received after the stipulated date will not be entertained.

5. It is requested that the officers may be advised not to send their applications to WCO directly. Further, they should not enter into any correspondence with WCO in this regard. The application of selected officer will be sent to WCO by the Board and the selected officers will be intimated by this office.
