
- (a) Senior Intelligence Officer

While forwarding the name of willing officers the following information may please be provided:

- (a) Complete bio-data and willingness of the officers along with history of posting.
 - (b) ACR/APAR grading for the last 05 years (FY 2014-15 to 2018-19) duly verified and attested by the competent authority.
 - (c) Vigilance Clearance and
 - (d) No objection certificate from the cadre Controlling Authority to relieve said officer in the event of his/her selection.
3. It may be brought to the notice of all the applications that once they are selected, they will not be allowed to withdraw their application. The appointment will be for the period of 02 (two) years from the date of joining. However, while working in the Directorate, if their conduct and work is not found to be satisfactory, they shall be prematurely reverted to their parent Commissionerate, without assigning any reason.
4. It may please be noted that applications received through proper channel will only be entertained. The last date for submission of application is 28.02.2021.
