Sub : Preparation of panel for selection of Superintendent/AAD on  
deputation in the office of Additional Director General of Audit,  
Ahmedabad.

Willingness is invited to fill up 2 (two) posts of Superintendents/AAD in the office of the Additional Directorate General of Audit, Ahmedabad Zonal Unit, Ahmedabad. One vacancy is to be filled on urgent basis and another one vacancy is for the panel year 2020-21 (to be filled up in the month of December 2020).

2. These posts will be filled up on deputation basis from amongst the officers of similar rank working in the formations of Customs, GST & Central Excise or officers holding analogues posts in the Directorate General / Directorates under the CBIC in the same pay scale.

3. Such officer selected for posting in this Directorate would normally be appointed for a period of 3 years, extendable by another 2 years.

4. Applications of the interested and eligible officers may be forwarded to this office with their particulars viz. name, address, educational qualification, date of birth, present posting, date from which present posting held, scale of pay, experience, ACR grading of last five years and also "No Objection Certificate" and vigilance clearance from the concerned Commissionerate/Directorate by 31.05.2020. Applications of officers who are not eligible as per above criteria may not be forwarded to this office. Advance applications may also be sent by email on the address mentioned above. Candidates eligible as per existing provisions for posting on deputation basis will only be considered for selection as per the CBIC guidelines and policy.

5. It may also be brought to the notice of the willing officers that once they are selected, they will not be allowed to withdraw their name and also will not be relieved till the expiry of the tenure of three years. Selected officers will have to make their own arrangement for residential accommodation. In case, while working in this Directorate, the work and conduct of the officer is not found to be satisfactory, the officer is likely to be relieved back to the parent Commissionerate/Directorate even before completion of the deputation period.
