Subject : Preparation of panel for appointment of **Senior Intelligence Officer** in the Directorate of Revenue Intelligence, Zonal Unit, Ahmedabad in the Pay Scale of Pay Matrix Level - 8 & 9 Pay Matrix Scale - Rs. 47,600 - 1,67,800/- on **Deputation Basis** - Reg.

The Directorate of Revenue Intelligence, Zonal Unit, Ahmedabad is in the process of drawing up a panel of suitable candidates for filling up posts of **Senior Intelligence Officer** at **Zonal Unit, Ahmedabad**. It is proposed to fill up these vacancies by appointing suitable officers from the grade of Superintendent of Customs & Central GST on **Deputation Basis**.

2. It is requested that directions may kindly be issued to bring the above to the notice of all the formations under your jurisdiction and that the applications of willing officers may kindly be forwarded to this office. While forwarding the names of willing officers, it is requested that the following information about them may also be sent for the purpose of evaluation of their suitability for this Directorate.

- (i) Willingness letter of the Officers along with **History of previous postings**;
- (ii) **ACR / APAR Gradings for the last 5 years duly verified and attested** by the Additional / Joint Commissioner (P&V) and
- (iii) **Vigilance Clearance.**

3. The selected officers, while working in the Directorate of Revenue Intelligence in the grade of Senior Intelligence Officer on Deputation Basis, will be entitled for deputation allowance as admissible. Normally, the Deputation is for a period of Five Years, which is extendable by another two years, subject to the willingness of the officer, his / her performance, concurrence of his parent Commissionerate and approval of the competent authority. It may be made clear to the willing officers that the option once exercised would be final and in the event of selection, they will not be allowed to withdraw the same. Also, that they will have to make their own arrangements for residential accommodation.

4. Further, as per Para IV of Ministry's F. No. A-35017/28/92-AD.IIIB dated 30.06.1994 officers posted in certain charges / organization / assignments are required to complete the "Cooling Off" period of not less than two years before posting in Directorate of Revenue Intelligence. However, the concerned Chief Commissioner of Customs / Central GST have the power to relax the "Cooling Off" period in deserving cases.

5. The undersigned would be obliged if the above information / details is arranged to be furnished to this office by 28.02.2020.


