Sir/Madam,

Sub:- Preparation of panel for appointment of officers of various cadres on loan/local transfer basis in the Directorate General of GST Intelligence (DGGI), Guwahati Zonal Unit and its Regional Units viz Aizawl, Agartala, Imphal, Dimapur, Itanagar & Shillong – reg.

Directorate General of GST Intelligence (DGGI), Guwahati Zonal Unit is in the process of drawing up a panel of willing and suitable candidates for filling up the posts of officers/staff of various cadres on loan/local transfer basis. The anticipated vacancies after November 2021 are enumerated in the **Annexure** given below.

2. It is proposed to fill up the vacancies by appointing suitable candidates from respective grades of officers/staff of Central Tax and Customs respectively on **loan basis**.

3. Normally, the posting on loan basis is for a period of two years, which may further be extended for one year with concurrence of the officer's Parent Commissionerate and approval of the competent authority.

4. During the posting on loan basis, the pay and other allowances of the concerned officer(s) shall be drawn from their respective Parent Commissionerate(s).

5. It is requested that this Circular may please be brought to the notice of all the formations under your jurisdiction and the applications of the willing officers may be forwarded to this office furnishing the following particulars.

1. Complete Bio-data and willingness letter of the officer along with history of previous postings,

2. ACR/APAR grading for the last 5 (five) years.

3. Vigilance Clearance certificate,
4. No Objection Certificate from the Cadre Controlling Authority to relieve the officer in the event of his/her selection.

The above information may be furnished to this office by **25.10.2021**.
