Only applications of IRS(C&CE) Group 'A' officers received through proper channel will be entertained.**

This is regarding filling up of posts in the grade of Addl. Director/ Joint Director (Director/ Deputy Secretary level) against the encadred posts of IRS (C&CE) in this Bureau. In this connection, D.O. letter of even number dated 22.06.2020 addressed to Additional Secretary, D/o Revenue may be referred to.

2. The matter was taken up by the Revenue (HQ) with CBIC for encadrement of the said post vide this Bureau's O.M. dated 27.08.2019 and 12.06.2020. However, no officer has been posted against the said post. There are 5 sanctioned posts of Director/ Joint Director level meant for Central Staffing Scheme/ Deputation/ encadred to CBDT/ CBIC. Out of these 5 posts, two posts are technically encadred with CBIC.

3. Presently, only two posts are filled up and three posts are lying vacant. Out of these two incumbent officers, one officer namely Shri S.K. Bhatnagar (Cadre CBIC) has requested for his premature repatriation and his request has been forwarded to DoR(HQ) and CBIC as the officer is anticipating his promotion in near future to the post of Commissioner in his parent cadre i.e. CBIC. Another incumbent officer is completing his tenure under Central Staffing Scheme in September 2020. As such, this Bureau is in dire need of filling up the posts lying vacant in the grade of Addl. Director/ Joint Director on urgent basis. In summary, one post encadred for CBIC is already vacant and other is likely to be vacant on account of repatriation of Shri S.K. Bhatnagar.

4. Considering the urgency of the matter, I would be grateful if you kindly look into the matter personally and direct the concerned officers to circulate the willingness of the officers of CBIC so as to facilitate the posting of officers by DoR.
