
Subject:-Posting on loan basis to Directorate General of Anti-profitteering, New Delhi- reg.

Kind attention is brought to F.No. 11013/12/2019-Ad.IV dated 27/05/2020 in which CBIC has decided that every Cadre Controlling Authority can post upto 10% of their sanctioned strength (meant for posting on loan basis to Directorates) to the Directorates outside the jurisdiction of the CCA, at the discretion of Chief Commissioner of the Zone.
