The Union Budget for 2021-22 is likely to be presented in Jan/ Feb 2021. In this context, suggestions and inputs in respect of indirect taxes are invited from field offices which serve as valuable inputs for formulating proposals in the Budget.

2. The suggestions *inter-alia* may relate to change in duty rates/ rationalization of duty rates for specific commodities, scope of notifications and conditions relating thereto, implementation aspects and the issues in disputes/audit objections, issues of interpretation and other matters concerning law and procedure. The utility of certain continuing exemptions may also be identified and forwarded to the Board along with your suggestion.

2.1 To enable proper consideration, the proposals should be accompanied with all relevant details such as duty incidence, volume and value of import/ domestic production, price information etc. It may be noted that GST related changes are not examined as part of Annual Budget exercise. However, suggestions related to GST issues are also welcomed. These would be examined at appropriate stage.
