1. **Administrative Changes:-**

- Order regarding assignment of the Member, CBIC, has been issued vide Office Order No. 62/2019 dated 07.05.2019.
- Order regarding promotion of IRS Officer to the grade of Joint Commissioner on ad-hoc basis, has been issued vide Office Order No. 63/2019 dated 08.05.2019.

2. **Legislative Changes:-**

- Notification No. 21/2019-Cus(ADD), dated 09.05.2019 has been issued to amend Notification No. 23/2013-Cus(ADD), dated the 10.10.2013 to extend the anti-dumping duty on ductile iron pipes originating in, or exported from China PR till 23.06.2019.
- Notification No. 01/2019-Central Excise dated 09.05.2019 has been issued to further amend Notification Nos. 20/2015-Central Excise and Notification No. 21/2015-Central Excise both dated 08.04.2019 to incorporate procedure for utilisation of paperless MEIS and SEIS scrips.
