3. The interested bidders will have to send the Demand Draft only to tune of Rs.5000 as security/EMD in favour of The Commissioner, CGST Goa and payable at Goa at the following address:

4. The Goods offered for disposal can be inspected on any working day between 10.30 AM to 05.00 PM from 21.01.2021 to 15.02.2021.
5. The entire sale/bid value with applicable taxes shall be deposited by the highest bidder within 15 days from the date of issue of sale letter. The successful bidder has to submit a DD in favor of The Commissioner, CGST Goa and payable at Goa of amount equivalent to the GST amount at the tax rate applicable on the total sale value. This DD will be returned to the bidder after successful filing of GST return specifying the GST applicable on total sale value paid to the Government.
6. The possession of goods offered for disposal will be given to highest bidder on the receipt of full amount of bid value after completing all the formalities.
7. The highest bidder/purchaser will have to remove the goods **within 15 working days** at their own cost from the date of issue of sale letter to the highest bidder.
8. In case, if the highest bidder does not lift the Condemned Items within 15 working days, the bid security/EMD deposited by him shall be forfeited without any communication. Thereafter, Condemned Unserviceable Stores Items will be offered to the second highest bidder at the price offered by highest acceptable bidder.
9. **Demand Draft of EMD** or exemption related document should reach above address before the date of opening of the technical bid otherwise the bid will be considered as nonresponsive. The EMD will be refunded to all unsuccessful bidders. The EMD submitted by the successful bidder will be adjusted in the amount to be paid by the bidder.
10. In case of any dispute arises relating to any aspects of this contract between two parties, the decision of the Commissioner, CGST Goa shall be final and binding on the successful/highest bidder.
