E-Tender Notice No. 06/2021-22

E-Tenders are hereby invited from the reputed parties/firms for repairing of CAT-III-A,(Hull No.016VN-9004) Narmada Boat (Length-09 M,Width- 3 M, Displacement-1.5 Tonnage, Draft-1.43M and Max. Speed- 30 Knots) lying at Old Bandar Port, Near old custom house Porbandar, as per below mentioned specifications. Total consolidated rate inclusive of all taxes & other charges with warranty period of the service should be submitted. All such consolidated quotations should be submitted by online mode on or before 03.06.2021(before 5:00 P.M.). Quotation received after the due date will not be considered.

2. The following Defects and damages are to be rectified by the applicant.

1. Servicing of both the OBM engines.
2. Repairing of fuel pump of Port OBM.
3. Replacing the Thermostat valves of both OBM.
4. Servicing of the Alternators of both OBM.
5. Replacing onenumber of Trim relay.
6. Servicing of both remote control throttles of OBM as both are hard to operate.
7. Replacing the complete electrical wiring.
8. Servicing of sea water cooling pipes/systems of both OBM as they are choked.
9. Servicing of GPS display as it is malfunctioning.
10. Servicing of one number of sea suction valve.
11. Replacing both sea water pump impellers.
12. Replacing the 02 numbers of Battery switches.
13. Repairing of Stand of Echo sounder.
14. Replacing both main fuel filters as they are corroded.
15. Replacing all the 06 numbers of Zinc anodes.
16. Servicing of 01 number of Fire extinguisher bottle.
17. Replacing the 12 numbers of Spark plugs of both OBM.
18. Fibre work is required to be done to fix the side railing as the railing base is uprooted at 08 places.

5. Terms & Conditions:-

- The vessel Cat III Narmada is stationed at Old Bundar, Porbandar (Gujarat). The vessel can be inspected for verification & assessment of defects & routines and requirement of spares by the vendors (Repairing agencies) at any working days before submitting quotation. For this purpose, the office of the Deputy Commissioner, Custom Division, Porbandar may be approached.
- Quotation submitted by the bidders shall be valid for the period of minimum 01 (ONE) year from the date of opening of financial bids.
- Genuine spares procured from the OEM / OEM authorized dealers only are to be used for rectification of defects/routines of Main engines, ASD propulsion systems, Gear boxes, generator etc. Old spares are to be handed over to the custom Department.
- Services of OEM representatives are to be utilized for defects rectification / routines of Main engines, ASD propulsion systems, Gear boxes, Generator and their associated systems etc.
- All spares, consumables, oil & lubricants, paints etc. which are required to carry out repairs/ routines / trials shall be supplied by the vendor including crane services/transportation.
- Work carried out shall be guaranteed for 02 (TWO) years from the date of satisfactory sea trials of the vessel. If any machinery or equipment replaced with new one, their warranty will be applicable as per manufacturer's term & condition and the warranty certificate is to be submitted to the Customs department.
- All the test / trials / service / calibration report of machineries & equipment are to be submitted to the Customs department for evaluation and record.
- All repairs/routines work and satisfactory sea trials at full load of all the machineries & equipment shall be completed within 03 (Three) months from the date of issuing Work order. In case, if repairs / routines work are not completed within stipulated time frame (i.e. 03 months), liquidated damage (LD) of Rs. 25,000/- per week shall be deducted from the bill for a period of 01 (One) month. Thereafter, liquidated damage (LD) of Rs. 50,000/- per week shall be deducted from the bill till completion of satisfactory sea trials of the vessel.
- After completion of all repairs & routines work, full load sea trials is to be conducted to check and ensure satisfactory performance of all machineries, equipment and Systems fitted on board.
- No growth of work will be entertained once work order is issued.

- The bidding amount for the whole work of repairing of boat should not exceed Rs 5,00,000.
